Gönenç Gürkaynak, Founding Partner and Managing Partner, ELIG, Attorneysat-Law

Mr. Gönenç Gürkaynak is a founding partner and the managing partner of ELIG, Attorneys-at-Law, a firm of 55 lawyers based in Istanbul, Turkey. Mr. Gürkaynak graduated from Ankara University, Faculty of Law in 1997, and was called to the Istanbul Bar in 1998. Mr. Gürkaynak received his LL.M. degree from Harvard Law School, and is qualified to practice in Istanbul, New York, Brussels and England and Wales (currently a non-practising Solicitor). Before founding ELIG, Attorneys-at-Law in 2005, Mr. Gürkaynak worked as an attorney at the Istanbul, New York and Brussels offices of a global law firm for more than eight years.

Mr. Gürkaynak heads the competition law and regulatory department of ELIG, Attorneys-at-Law, which currently consists of 26 lawyers. He has unparalleled experience in Turkish competition law counseling issues with over 18 years of competition law experience, starting with the establishment of the Turkish Competition Authority. Every year Mr. Gürkaynak represents multinational companies and large domestic clients in more than 20 written and oral defences in investigations of the Turkish Competition Authority, about a dozen antitrust appeal cases in the high administrative court, and over 45 merger clearances of the Turkish Competition Authority, in addition to coordinating various worldwide merger notifications, drafting non-compete agreements and clauses, and preparing hundreds of legal memoranda concerning a wide array of Turkish and EC competition law topics.

Mr. Gürkaynak frequently speaks at conferences and symposia on competition law matters. He has published more than 100 articles in English and Turkish by various international and local publishers. Mr. Gürkaynak also holds teaching positions at undergraduate and graduate levels at two universities, and gives lectures in other universities in Turkey.

Dr Murat Çetinkaya is a Member of The Board at Turkish Competition Authority (TCA). Dr. Çetinkaya began to serve as an assistant competition expert at the TCA in 1997. In 2001, he was appointed to competition expert position. As a case officer, he has handled cases about different sectors both as a member and a leader of the case teams. He also held the position of acting Head of Department II within the TCA from 2007 to 2009. He was appointed to the Competition Board, by Council of Ministers in 2009. He has extensive experience and a number of publications in the field of competition law and economics, competition policy and regulation. Amongst other things, he is one of the co-editors of the Rekabet Dergisi (Competition Journal) and is a member of the Advisory Board of Hacettepe University Energy Markets Research and Application Center. He has held undergraduate level lectures on "Law and Economics" and "Industrial Organization and Public Policy" at several universities in Turkey. Dr Çetinkaya is a graduate of Ankara University the Faculty of Political Science. He also holds an MSc in management economics from University of Essex, UK, and a PhD degree from Hacettepe University Institute of Social Sciences.

For the last 8 years, he has been working at the Bilgi University Faculty of law as an assistant professor and has been lecturing on contract law, economic analysis of law and antitrust law at the graduate and the undergraduate programs. He has also been adjunct professor at the Bilkent University Faculty of Law since 2008 and has been teaching law and economics at the LL.M. Program. He is also the founder and the director of the Competition Law and Policy Research Center at the Bilgi University, which is considered as the leading NGO in competition law field.
